Mr Smith

When Mr. Smith filed a return showing zero self employment income, HMRC initiated an enquiry to look at the amount of interest declared. They had incorrectly thought that the interest had been understated; it hadn't, therefore no additional tax was payable. The costs of professional fees for this very simple matter would have amounted to nearly £900.

Building Firm

HMRC questioned Building firm 'X' about Construction Industry Scheme payments. The investigation found that no additional tax was payable; in fact, the firm received a refund from HMRC. Despite this, professional costs would have been over £2,100.
